THE ORGANIZATION'S TWO SPECIALTY VETERINARY HOSPITALS IN LOS ANGELES AND SAN FRANCISCO BAY-DELTA RESCUE AND REHABILITATE OVER 4,000 NATIVE AQUATIC BIRDS EACH YEAR, AND RELEASE THEM BACK INTO THE WILD. THIS DAILY RESCUE AND REHABILITATION WORK MAINTAINS AND DEVELOPS THEIR FACILITIES AND THEIR STAFF AND VOLUNTEERS' SKILLS THAT ENABLE THEM TO RESPOND RAPIDLY TO CRISIS EVENTS WHEN THEY OCCUR.

IT MAINATINS A PROFESSIONAL WILDLIFE RESPONSE TEAM COMPRISED OF TRAINED AND EXPERIENCED REHABILITATORS, VETERINARIANS, BIOLOGISTS AND OTHER EXPERTS. PREPAREDNESS SERVICES INCLUDE WILDLIFE CRISIS RESPONSE PLANNING AND TRAINING FOR FIRST-RESPONDERS.
